6.03.24 ATTENDEE REPORTS AROUND THE ROOM

➤ **Murray Hall – Chief Bushfire Control Officer**

- Low incidence of fire within the Shire this season. Couple of potential large fires shut down miraculously by fast response. Literally cut off fire metres from massive fuel loads and looming protracted bad weather.
- Supported Pingelly, Corrigin and Beverley fires. Lightning and header fires.
- Ongoing mitigation work. Ranging from forestry mulching, breaks, cool burning, spraying, as per Shire planning.
 - Recommended railway corridor to be better mitigated.
 - More mitigation planned for Autumn in risk areas north of town.
- Been a slight increase in new volunteers joining brigades.
- Still advocating for improved communication between our region and Wheatbelt Goldfields Region.
- One shed for West Brigade currently being build and soon to be finished.
- East shed going to tender and expected before next fire season.
- Now moved into Restricted Season. Permits restricted with due to Fire Danger Rating / FBI index.
- Reporting to DFES Comsen to register burn.
- ROAC – focus on safety and procedure to prevent injuries.

➤ **Anna Erickson – DPIRD**

- Recovery operations continuing from Albany fire.
- Waiting on reports from Eucla flooding. Transporting of stock will be impacted by floods.

➤ **Michael Phillips – Dept. of Communities**

- Structure changes within Department of Communities.
- Based in Northam.

➤ **Jason Carrall – Acting AO Narrogin**

- Pingelly had a number of fires.
- Cuballing had a number of deliberately lit fires.

STATE EMERGENCY MANAGEMENT DOCUMENTS

The SEMC has approved changes to the suite of State Emergency Management (EM) Documents within the State EM Framework. These changes include the development of an **All-Hazards Restricted Access Permit System (RAPS) Guideline**, a detailed review of the interim **State Hazard Plan – Severe Weather**, and a new **State EM Risk Management Guideline**.

In addition to the documents mentioned above, the following State EM documents have been amended:

- State EM Policy – Consequential amendments resulting from the new RAPS Guideline and Risk Management Guideline
- State EM Plan – Consequential amendments resulting from the new RAPS Guideline
- State EM Procedure – Consequential amendments resulting from the new Risk Management Guideline
- State EM Glossary – Consequential amendments resulting from the new Risk Management Guideline
- State Hazard Plan Fire – Consequential amendments resulting from the new Risk Management Guideline
- State EM Traffic Management in Emergencies Guideline – Consequential amendments resulting from the new RAPS Guideline.

The SEMC has approved and published two new State Emergency Management documents, the **State Support Plan – Emergency Relief and Support** and the **Local Emergency Management Committee Handbook**.

State Support Plan – Emergency Relief and Support

Several key changes were made to the Plan including;

- The change to terminology from 'welfare' to 'emergency relief and support' and 'welfare centre' to 'evacuation centres'.
- Greater clarity of the emergency relief and support services provided within the six functional domains.
- Greater clarity of Communities role in supporting Disaster Victim Identification services in respect to a major emergency.
- Greater clarity of Communities role as the State agency responsible for leading the social domain in the recovery phase of an emergency.

Please review your internal emergency management documents to reflect new terminology used within the Plan.

Local Emergency Management Committee Handbook and useful tools

The LEMC handbook provides local governments with a summary of the actions and best practice principles as required under section 38 – 40 of the *Emergency Management Act 2005*, State Emergency Management Policy, procedures, and guidelines.

The LEMC Handbook provides a summary of the WA emergency management arrangements, key roles, and responsibilities and best practice advice for the administration of LEMC.

The Handbook also includes sample LEMC Terms of Reference and Meeting Agenda templates, which can be downloaded from the [SEMC website](#).

Amendments to State Emergency Management documents

State EM Policy has completed consequential and statement of fact amendments to most of the State Emergency Management documents. The changes relate to:

1. The change in terminology from 'welfare' to 'emergency relief and support' and related terms following SEMC approval of the State Support Plan – Emergency Relief and Support.
Please note: While the amendments log provides an overview of all items that have been updated within the suite, a detailed log is not provided for each reference to these terms within the State EM Framework.
2. Consequential amendments to reflect the outcomes of the 2023 SEMC Subcommittee review, which came into effect 1 July 2023.
3. Consequential amendments to reflect the revised State EM Capability Framework, approved by SEMC on 4 October 2023.
4. Statement of fact amendments to correct minor issues raised by EM stakeholders and to improve accessibility, approved by the SEMC Executive Officer.

Amendments to Traffic Management During Emergencies Guideline

The SEMC Executive Officer has approved a statement of fact change to the Traffic Management During Emergencies Guideline in support of the Wooroloo Bushfire Review Recommendation 8: *DFES should consider establishment of road clearing capability to complement bushfire response, with the sole purpose of clearing roads to provide safe return of residents as soon as possible after fire.*

8.03.24.01 MEDIA RELEASE – \$2. MILLION FUNDING AWARDED TO WA DISASTER REDUCTION INITIATIVES – 24 FEBRUARY 2024

A range of projects aimed at reducing the risk and impact of natural disasters in Western Australia will share in \$2.5 million of funding under the National Disaster Risk Reduction (NDRR) Grant Program.

Western Australia will share in \$2.5 million of funding under the National Disaster Risk Reduction (NDRR) Grant Program.

Following a record number of applications, 15 successful initiatives are set to make an impact in communities across the State, including protection from extreme heat, cyclone shelters, aircraft infrastructure in remote areas, and artificial intelligence to detect bushfires early.

The NDRR Grant Program is jointly funded under a National Partnership Agreement between the Australian and Western Australian Governments to benefit communities into the future.

Federal Minister for Emergency Management, Murray Watt said the Albanese Government was committed to working with all levels of government, community members and organisations to reduce the risk and impact of natural disasters.

The Australian Government will provide more than \$12.5 million to Western Australia under the jointly funded National Partnership Agreement on Disaster Risk Reduction over five years from 2019-20 to 2023-24.

Managed by the Department of Emergency Services (DFES), Emergency WA has been the community's trusted source of authoritative, accurate and timely emergency information since 2016 – helping people impacted by emergencies make decisions to keep themselves safe.

The platform is now entering an exciting new phase as DFES and Genvis work to provide a nation-leading emergency information platform capable of delivering faster, more personalised and targeted warnings during emergencies.

The partnership is part of a multi-year project delivering innovative improvements to Emergency WA, including nationally consistent warnings through the Australian Warning System.

The new functionality will be rolled out in a phased approach, and will include an app along with translated warnings, the ability to set watch zones, integration with in-home and wearable smart devices and new accessibility features.

Emergency WA continues to grow as the State's one-stop shop for emergency information, with many State Government entities joining the platform to help Western Australians find the information they need to stay safe.

Current users include the Department of Biodiversity, Conservation and Attractions, as well as the Departments of Health and Education, and Western Power.

8.03.24.03 MEDIA RELEASE – GOVERNMENT ANNOUNCES MULTI-MILLION DOLLAR BOOST TO REDUCE FIRE RISK – 19 DECEMBER 2023

The Cook Government has announced a \$4.45 million program to support 24 local governments reduce bushfire risk near their local communities.

- 24 local governments receive grants in latest round of Mitigation Activity Fund
- Funding will support more than 600 mitigation activities to reduce bushfire risk
- Over \$52 million allocated to 70 local governments since program began in 2017

Emergency Services Minister Stephen Dawson said the funding would help these local governments create new firebreaks and carry out planned burns when conditions are suitable.

The 24 local governments, located from Albany to Dandaragan, will share in the \$4.45 million allocated through the second round of the 2023-24 Mitigation Activity Fund (MAF). First introduced in 2017, the MAF supports local governments so they can manage high-risk areas of the State. It is available to those with an endorsed Bushfire Risk Management Plan.

The latest round of funding will pay for over 600 mitigation activities in the Great Southern, South West, Goldfields-Esperance, Mid West-Gascoyne, Wheatbelt and metropolitan regions.

Well-managed mitigation activities reduce bushfire risks without adversely affecting the environment, wildlife and ecosystems. These activities include building fire breaks, reducing fuel loads and carrying out hazard reduction burns.

In addition to mitigation activities the Cook Government is investing more than \$140 million into providing new equipment, resources, personal protective clothing and facilities to support our frontline fire and emergency services.
